CONTRACT RATE:	\$2.40 PER 1,000 LBS OF GROSS CERTIFIED LANDING WEIGHT (minimum fee \$25.00 per landing)
NON-CONTRACT RATE:	\$3.55 PER 1,000 LBS OF GROSS CERTIFIED LANDING WEIGHT (minimum fee \$25.00 per landing)

FLOWAGE FEES

(APPLIES TO ANY AIRCRAFT NOT REQUIRED TO PAY LANDING FEES)

\$0.07 PER GALLON (corporate and private)

TERMINAL FEES

COUNTER CHARGE:	\$150.00 PER OPERATION
